Carousel Bags Privacy Policy

Carousel Bags (“we”, “our”, “us”) provides this Website (“Site”) located at www.carouselbags.com for your use, including product rental and sales services (together with the Site and all content and information provided therein, the “Services”), subject to the Terms of Service, this Privacy Policy, and all applicable laws and regulations. Please read this Privacy Policy carefully. By accessing the Site or using any of the Services, you acknowledge that you have read and understood this Privacy Policy and any modifications made to them from time to time. We reserve the right to revise this Privacy Policy, so please check back periodically for changes. Your continued use of the Site following the posting of any changes to this Privacy Policy constitutes your acceptance of those changes. All changes are effective immediately when posted and apply to use of the Site thereafter.

Information Collected

We collect customer information to enhance your experience. This Privacy Policy is intended to assist you in understanding what information we gather about you when you visit our website, how we use and share that information, and the safeguards we have in place for that information. This Privacy Policy applies to the information collected on the Site.

We gather navigational information during each visitor's use of our Site. In the process of gathering navigational information, non-personally identifiable information (i.e. domain type, browser version, service provider and IP address) may be collected. The navigational information tells us about the use of our website by visitors, including the areas of our site that are most visited or the time of a last visit to a page on our Site. It also tells us about the technical efficiencies of our Site and Services (i.e. the time it takes a visitor to connect to our website or download pages). The navigational information helps us better understand a visitor's experience and improve upon that experience by recognizing and delivering more of the features, services, and products our members prefer.

Your Account

We may ask you to provide personal information when you establish or update an account, manage your account, create a rotation, or manage your text alerts, participate in a survey, shop online, check the status of an order, review order history, provide a review about our products, or search for products on our site or provide information about your handbag preferences. Categories of information collected include name, address, email address, order information, telephone number, credit card/debit card information, birth month and day.

Access to parts of the Services requires the creation of a user account, including a user name and password that you choose upon registration. During registration you are required to give

truthful contact and demographic information. We use this information to contact you about the products and Services on the Site and to provide notifications in regards to your membership and deliveries. You are solely responsible and liable for any authorized or unauthorized access to your account by any person. You agree to bear all responsibility for the confidentiality of your account information and all use or charges incurred from use of the Services with your account. You agree to notify us promptly at hello@carouselbags.com of any unauthorized use of your account or password.

Communications

You may receive communications from us, including email, text messages, calls, and push notifications, for the purposes of notifying you about the status of your order, sending you reminders, verifying order details, facilitating personal authentication, and providing or requesting other information. We may contact you by telephone calls or text messages at any of the telephone numbers provided by you. Standard message and data rates charged by your mobile carrier may apply to these communications. You may opt out of receiving text messages by replying “STOP” to a text message you receive from us or by emailing hello@carouselbags.com. However, by opting out of receiving text communications or other communications you may miss information that could affect your use of our Services.

Your Content

If you post, upload, or make available to us or otherwise submit to or through us as part of your use of the Services, including the Site or social media channels, any information, data, text, images, files, links, software, chat, communication, or other materials, including but not limited to photos and reviews relating to your use of the Site or products, we may use, reproduce, transmit, display, exhibit, distribute, index, comment on, modify, create derivative works based upon, and perform the content in all media formats and distribution methods now known or hereafter devised without further notice to you. However, we will not sell your personal information to any third parties.

COPPA protects the online privacy of children under 13 years of age. The Site is not directed toward individuals under the age of 18, and we request that such individuals do not provide personal information through the Site.

Third-Party Account Credentials

When you provide us with your third-party account credentials to such services as Facebook, Twitter or Paypal, some content and/or information in those accounts may be transmitted into your account with us. However, information transmitted to our Site from your third-party account will be covered by this Privacy Policy.

Security

The security of your information is important to us, including, but not limited to, the personal information collected via the Site. We use reasonable security measures to protect against the loss, unauthorized access, misuse, alteration and destruction of personal information under our control. Although we make good faith efforts to maintain the security of such personal information, no method of transmission over the Internet or method of electronic storage is completely secure and we cannot guarantee that it will remain free from unauthorized access, use, disclosure, or alteration. Further, while we work hard to ensure the integrity and security of our network and systems, we cannot guarantee that our security

measures will prevent hackers or unauthorized persons from illegally accessing or obtaining this information. We keep personal information for no longer than necessary for legitimate business purpose or as required by law.

As part of securing personal data stored on our servers, we restrict access to personal information to employees or contractors who need to know that information in order to operate, develop, or improve the Services. These individuals are bound by confidentiality obligations and may be subject to discipline, including termination and criminal prosecution, if they fail to meet these obligations.

If we learn of a security breach, we may attempt to notify you electronically so that you can take appropriate protective steps. By using the Services or the Site or by providing personal information to us, you agree that we can communicate with you electronically regarding security, privacy, and administrative issues related to your use of the Services.

If a security systems breach occurs, we may post a notice on the Site and may send email to you at the email address you have provided to us. Depending on where you live, you may have a legal right to receive notice of a security breach in writing. This notice paragraph applies to users of the Services and Site.

Change of Ownership

In the event of a change in ownership or a merger with, acquisition by, or transfer or sale of all or a portion of our assets to, any other entity, we reserve the right to transfer all of your personal information, including emails, to that entity. We will use reasonable efforts to notify registered users of any such transfer to an unaffiliated third party by a posting on the Site or by email to your email address that you provided to us, as chosen by us in our discretion.
